

Okanagan 4 Ukraine privacy policy

In order to treat your privacy with respect, Okanagan 4 Ukraine has the following policy. Okanagan 4 Ukraine will manage all personal information in accordance with [the privacy laws of British Columbia](#). By visiting and using <https://www.okanagan4ukraine.org>, you consent to this policy.

Okanagan 4 Ukraine may collect information from you when you voluntarily sign up for e-mails, newsletters, surveys, webinars, events, presentations, or when you leave comments, fill out a form, or otherwise contact Okanagan 4 Ukraine.

The information collected may include your name, e-mail address, address, or phone number. But if you're just visiting the website and don't wish to sign up for anything, then, of course, you don't need to provide any information!

The purpose of collecting this information is to send e-mails and plan programs and events.

Okanagan 4 Ukraine may collect domain information and cookies to analyze user patterns and website performance.
